Subject: Implementation of Uniform Assessment and Evaluation Scheme for all Academic Programmes of MRSPTU.

In pursuance of the recommendations of the Committee constituted vide Office Order No. DAA/MRSPTU/2026/5196 dated 05.06.2026 and the Minutes of Meeting held on 08.06.2026, regarding formulation of a Uniform Assessment and Evaluation Scheme, and in partial modification/supersession of the existing assessment provisions contained in the MRSPTU Choice Based Credit System (CBCS)-2016 Regulations, the Competent Authority has approved, in anticipation of the approval of the Academic Council vide Diary No. VC/328 dated 09.06.2026, the following Uniform Assessment and Evaluation Scheme for implementation across all academic programmes of the University.

The revised scheme has been formulated in consonance with the provisions of the MRSPTU CBCS Regulations-2016, which prescribe a 40:60 assessment ratio for theory courses and a 60:40 assessment ratio for laboratory/practical courses, while empowering the University to specify detailed components of internal assessment and evaluation.

Accordingly, the following scheme shall be implemented with effect from the Academic Session 2026-27 for all programmes being offered at the University Main Campus, GZSCCET, PITs, PSAEC, Patiala, and all affiliated colleges/institutions of MRSPTU.

1. ASSESSMENT PATTERN FOR THEORY COURSES

1.2 Attendance Marks Distribution

Note: Eligibility to appear in the End Semester Examination shall continue to require a minimum of 75% attendance in the concerned course, as prescribed under the University Regulations.



3. GENERAL PROVISIONS

1. The above assessment and evaluation scheme shall be applicable to all academic programmes offered by the University and its affiliated/constituent institutions unless otherwise specifically approved under statutory bodies like PCI, NCAHP, CoA and any other Competent Authority.
2. Every subject shall continue to carry a total of **100 marks**, in accordance with the provisions of the MRSPTU CBCS Regulations.
3. The existing grading, promotion, eligibility, and examination provisions prescribed under the applicable University Regulations shall remain unchanged unless specifically modified through separate notification.
4. Principals, Directors, Deans, Heads of Departments, and Course Coordinators shall ensure strict compliance with the above assessment and marks distribution scheme.
5. Any deviation from the prescribed assessment structure shall require prior approval of the Office of the Dean Academic Affairs and the Competent Authority.
6. The purpose of this notification is to ensure uniformity, transparency, fairness, and consistency in the assessment and evaluation process across all institutions under the jurisdiction of MRSPTU.
