Subject: - Improvement of degree

The students who have completed the course but has failed to fulfill the minimum requirement for grant of degree or the student who wish to improve upon the CGPA/percentage can apply (**upto 02/11/2020**) to appear in the end semester examination starting from 4th November 2020 (**performa attached**).

The candidate has to pay examination fees of Rs. 700/- per semester in the form of Demand Draft in favour of Registrar, MRSPTU, Bathinda. The student can apply by visiting the university or he can send the form and DD by speed post.

It is to be noted that only those candidates can apply who are to complete duration of the degree in June 2020 (N + 2 for 2016 batch onwards and 2N for 2015 batch where N is the No. of years of course duration).

Also candidates must note that they can appear only in those subjects which they have already appeared during duration of degree and in maximum 5 subjects.
